Terms & Conditions:

I, _____ (Customer) _____ (Address) agree to the following terms and conditions for the rental of described services. _____ (Phone#)

Pricing & Payment:

1. Customer agrees to pay \$_____ (base fee) for the _____ yd. container which includes up to ___ tons of material as well as any overages incurred due to overloading at **\$95.00** per ton. Additional days after **10** days from delivery date _____ requested by the customer are **\$15.00** per day.
2. Customer is responsible for any additional fees assessed by the transfer station for certain items not allowed: Refrigerators & A/C units aka CFC (\$25ea), Auto batteries (\$10ea), Tires passenger (\$10ea)/ Truck (\$15ea), E-WASTE including TV's & Monitors aka CRT's (\$20ea), Mattresses and/or Box springs (\$20ea), Paint cans (wet), lawnmowers, and Propane tanks. ****Call your local Municipality for proper disposal instructions* ***
3. Payment for all base fees as well as any known additional rental time will be due upon delivery of the container. **Additional fees due to overweight or other fees not paid for upon delivery will be charged to credit card on file (Authorization Form attached).**

Use of Dumpsters:

1. While refuse dumpsters are in your possession, you will **NOT** place or allow to be placed into the dumpster:
 - A) Substances hazardous to health such as **toxic or corrosive materials** or liquids of any kind whether contained or not;
 - B) Cans, drums, or other containers of any kind unless they are empty and crushed; so incapable of carrying any liquid;
 - C) medical waste or animal carcasses of any kind or quantity;
 - D) Extremely heavy materials such as dirt, rock, or concrete.****Please let us know and we can arrange for more efficient options****
2. Fill any dumpster higher than the top of its sides and in such a manner as to prevent spillage of material while stationary or in transit;
3. Light fires in the dumpster;
4. Customer is responsible for any damages to the container other than normal wear and tear while in the customer's possession.

Access and Grounds Conditions:

The customer will be responsible for the provision of free and suitable access to and from the delivery site (including the removal and reinstatement of local obstructions) and for ensuring suitable ground conditions for the delivery, placement, and removal of the dumpster. No responsibility will be accepted for the damage to any surface and you should therefore take steps to protect surfaces (e.g. driveway, paving slabs, and soft ground) before delivery.
